## **1 Apologies for absence** – None.

- 2 **To receive declarations of members' interests and consider requests for dispensation** Full dispensation for Cllr. Haisman continues for item 6a). Partial dispensation for Cllr. Blake continues for item 6a).
- **3 To receive a report on correspondence** The Clerk referred to a letter from the owner of a business in Clare. It was proposed that the document provided by SALC 'Protocols for Public Participation in Council meetings' be adopted for use. Agreed unanimously. It was agreed that the wording of Town Council agendas be amended to replace '*Parishioners' Question time*' with '*Public Participation*' in accordance with the reference to members of the public in standing orders and the new protocol document. The Clerk will obtain further (written) confirmation from SALC that the amendment to the agenda is permitted.

# b) DC/14/0298/TCA – Angel Barn, Nethergate Street – Fell one Eucalyptus tree in rear garden

Cllr. Mallows proposed that the response be that there is no objection. Approved unanimously.

#### c) DC/14/0276/VAR – Lodge Farm, Chilton Street – Variation of Condition 17 (Parking and Turning) and Condition 18 (Approved Plans) of SE/13/0628 to enable the erection of a cartlodge

Cllr. Mallows proposed that the response be that there is no objection. Approved unanimously.

a) DC/14/0100/HH - The Swallows, 12 Hermitage Meadow – (i) Erection of single-storey side link extension between dwelling and outbuilding (ii) new porch (iii) conversion of garage to ancillary accommodation as amended

Cllr. Blake presented his objections to the application. Cllr. Blake then left the room.

Cllr Haisman presented his objections to the application and referred to his letter of objection sent to St Edmundsbury Borough Council. Cllr. Haisman then left the room.

Cllr. Godwin presented reasons for the rejection of the application.

Cllr. Mallows stated that some of the previous concerns have been addressed by the revised plans but that some concerns remained.

Cllr. Phillips (Chair) invited Mr Frere (the architect and agent to the applicant) to answer questions on the application.

Following questions and answers on ridge and eaves heights, flood risk, precedent setting and street scene, Cllr. Phillips proposed a secret ballot which was agreed unanimously. Cllr. Mallows proposed that the application be objected to because of concerns of precedent setting, that the

design is not in keeping with the character of the street, is significantly enlarged and that the roof is closer to the neighbouring property.3 Cllr.s voted in favour of the objection, 1 voted against and 4 abstained.
